

OPERATING PROCEDURES

INTRODUCTION

These Procedures define how Sailing and Power Boating is managed at Dart Sailability to provide a safe environment for all sailors and volunteers. Other aspects of the Management of Dart Sailability are defined in the Handbook.

NOTE:

These Procedures and the Handbook replace the the Handbook and Operating Procedures V21.1 dated April 2022 (HoPs).
